Education Committee

(a sub-committee of the Senate)

Terms of reference

- 1. To develop and recommend to Senate as appropriate the University's Strategy in accordance with the University's Strategic Plan and provide advice to the Senate and Council on all aspects of education, teaching and learning activities.
- 2. To identify and promote strategic initiatives in relation to:
 - implementation of key elements of the Education Strategy;
 - high-level themes of issues arising from quality assurance and enhancement mechanisms; and
 - relevant sector developments in learning, teaching and assessment.
- 3. In accordance with delegated authority and aligned with the priorities of the Education Strategy, approve on behalf of Senate:
 - policies relating to learning, teaching and assessment concerning all taught and
 postgraduate research programmes leading to Lancaster University awards and
 their constituent components; the development and introduction of new
 programmes, the modification of existing programmes, and the termination of
 programmes, in consultation with the Collaborative Partnership Sub-Committee,
 Academic Standards and Quality Committee, Faculty Teaching Committees and
 other committees as appropriate;
 - codes of practice and procedures relating to students and their studies (including teaching, learning and assessment; postgraduate research training and development; recruitment; admissions; the student academic experience), with regard to the University's commitment to equality and diversity, in consultation with the Student Experience Committee as appropriate.
- 4. To operationalise the implementation of the Curriculum Transformation Programme's four foundation principles, as delegated by Senate.
- 5. To monitor relevant internal and external developments to inform future education strategy and policies, making recommendations as appropriate to Senate.
- 6. To advise the Senate on the scope of the University's portfolio of taught and postgraduate research programmes, including across modes of teaching and across subject areas, and to recommend areas for development as appropriate.
- 7. Draw to the attention of the relevant resourcing bodies issues re: the provision and use of learning and student support resources (including library, IT, student advisory services, space/estates), and to make any necessary recommendations to Senate or other appropriate Committee.

- 8. To prepare responses on behalf of the University to relevant consultation proposals relating to education, teaching and learning from external bodies, in consultation with the Vice-Chancellor.
- 9. To advise the Pro-Vice-Chancellor (Education) on expenditure of the institutional allocation for the promotion of activities in relation to teaching and learning, in line with priorities set annually.
- 10. To advise the Senate, or other bodies on behalf of the Senate, on matters referred to the Committee by or on behalf of the Senate.
- 11. To create sub-committees and/or initiate working groups as required; to receive and consider reports and proposals from these; and to delegate to these aspects of the above in line with agreed delegated authority.
- 12. To monitor and report on progress with implementation of agreed policies, the Education Strategy and the Institute for Curriculum Enhancement to Senate.

Procedure

The deputy Chair for the Committee will be the University Academic Dean.

The Standing Orders set out a standardised approach to committee procedural arrangements, including membership terms, quoracy and declaring interests. All members are encouraged to read the Standing Orders available on the <u>Governance website</u>.

As per the University's Code of Practice on Freedom of Speech and Academic Freedom, all committees considering business that could affect compliance with free speech duties, in line with their delegated authority, are expected to have due regard for any impact on the University's duties to secure and promote the importance of freedom of speech and academic freedom. Any enquiries regarding this should be directed to the Director of Strategic Planning and Governance in the first instance.

The Committee will normally meet three times a year.

Education Committee works to ensure gender equality in its composition. The Chair of the Committee will interact with Faculty Executive Deans and the Students' Union to help to ensure gender equality.

The postgraduate research student term will be for three years or less, if they cease to be students of the University. If a person ceases to be eligible to the category by which they were appointed, their membership would cease at that point.

Written reports of meetings will go to Senate.

The Secretary of the Committee will be a member of staff from Governance Services.
